

Residential Care Awards 2024

The Residential Care Learning and Development Strategy (RCLDS) Residential Care Awards recognise exceptional work carried out in the field by Residential Carers. The RCLDS awards are held as part of the annual ResiROCKS celebration event - this year on Thursday, 10 October.

The RCLDS Residential Care Awards recognise, celebrate and encourage work of the highest standard in the provision of therapeutic residential care provided in Victoria that contributes to positive outcomes for children and young people living in residential care.

Nominating an individual or team is an easy way to publicly spotlight their outstanding achievements in working with children and young people in care.

The RCLDS Residential Care Awards are competitive, with some categories receiving a lot of nominations.

The panel will judge winners based on how well the nominee meets the award criteria outlined below in relation to the category in which they are nominated.

Be sure to provide as much information as you can in your responses, considering word limits, and include supporting documentation, including photos and videos where appropriate, to enrich your nomination.

Award categories

Awards will be offered in 7 categories:

Residential Carer Award

A person who has worked to achieve outstanding outcomes for children and young people living in residential care and demonstrates an ongoing commitment to learning and development.

Residential Team Award

A team within a residential house who have worked collaboratively to achieve significant, positive outcomes for children and young people living in residential care.

Leadership Award

A person who has demonstrated outstanding achievement and innovation in their leadership role, significantly impacting on residential care systems and outcomes for children and young people.

RCLDS Learning Award

Recognising a carer who has demonstrated commitment to learning and development, through regular attendance at training, including but not limited to RCLDS training.

Hall of Fame Award

Honouring an individual who has demonstrated outstanding dedication and commitment to the Residential Care sector with over 10 years of service.

Education Award

A person or team that has utilised innovative approaches in supporting educational success for children and young people living in residential care.

First Nations Cultural Engagement Award

An individual or a team that demonstrates a commitment to providing best practice and culturally appropriate care to First Nations Young people.



Application Information

This Information Pack assists in completing the nomination form.

Information on the Award criteria is contained in the package, and these are the points the judging panel will be looking for when making their decision. Please make sure you read the information pack carefully or your nomination may regretfully be declined.



General information

The Awards are open to any individual or group working in DFFH Out of Home Care funded residential care units in Victoria who contribute to positive and professional residential care of children and young people.

Applicants need to clearly specify the Award being applied for and complete all relevant sections on the nomination form.

Supporting documents may include photographs, videos, support letters etc. All submissions and supporting documents become the property of RCLDS; they cannot be returned and may be used to promote the RCLDS Forum and Awards. Please be mindful of what you send in and ask for permission from those featured.

Any work undertaken in 2023/4 is eligible.



Award criteria

The criteria the judging panel will use to make decisions are:

Residential Carer Award

For a Residential Care Worker who has demonstrated outstanding dedication and commitment to their role, which has led to positive changes to the lives of children and young people in residential care. Such a Carer demonstrates:

- 1. A high standard of therapeutic residential work, which has had a positive impact on the quality of life of children, young people and families.
- 2. A direct contribution to maintaining a safe, supportive and nurturing living environment for children and young people in their care.
- 3. An outstanding contribution to supporting their team and peers.
- 4. Commitment to learning and development and using this to model best practice and/or innovation.

Residential Team Award

For a residential team that has worked collaboratively and therapeutically to achieve significant and positive outcomes for children and young people whilst living in residential care. Such a team demonstrates:

- Cohesive and collaborative team culture focused on achieving positive outcomes for staff, children, young people, and families.
- 2. A commitment to learning and development.
- 3. Maintains a safe, supportive and nurturing living environment for children and young people in their care.
 - Innovative, collaborative practice with the wider community and sector to achieve improved outcomes for children, young people, and families.
- 4. Considers young peoples' voices in the delivery of individualised care.

Leadership Award

For a Residential Care Supervisor/Manager who has demonstrated outstanding leadership qualities in bringing about better outcomes for children and young people living in residential care and for staff. Such a leader demonstrates:

- 1. Outstanding achievement in their leadership role with positive outcomes for staff, children, young people, and families
- 2. Significant commitment towards a culture that embraces learning and skills development for staff
- 3. Collaborative sector and community partnerships



RCLDS Learning Award

The successful candidate must have demonstrated a commitment to ongoing learning and development through active participation in a range of learning opportunities, including RCLDS training over the last 12 months. Further to this, the applicant must:

- 1. Actively share new learning with team members and colleagues
- 2. Promote learning opportunities within the organisation as avenues to improve practice and act as a learning 'champion'.

Hall of Fame Award

For a person who has worked in residential care for a period of 10 years or longer. Such a person demonstrates:

- 1. A true commitment to the work of therapeutic residential care
- 2. Acts as a mentor/buddy to other residential care staff including new recruits.
- 3. An ability to form strong meaningful relationships with young people and often acts as an advocate for young people
- 4. A reliable and adaptive approach to a therapeutic residential care model
- 5. A willingness to change styles/approaches/systems to meet the ever-changing needs of residential care and the young people.

Education Award

A team or individual that demonstrates the use of creative responses and approaches in supporting the educational success for children and young people living in residential care.

- 1. Advocates for the young people in their care, throughout their education journey.
- 2. Seeks to provide opportunities for learning outside of the traditional structures of education.
- 3. Champions the children and young people, ensuring their voice is heard in decision-making.
- 4. Actively seeks opportunities for collaboration in the young peoples' best interests.

First Nations Cultural Engagement Award

An individual or a team that demonstrates a commitment to providing best practice and culturally appropriate care to First Nations Young people.

- 1. Responding and providing culturally appropriate care to First Nations children and young people within the residential home.
- 2. Actively seeking opportunities for First Nations young people to explore and learn about their culture and participate in cultural activities
- 3. Consultation and guidance with First Nations services to ensure appropriate responses and best practice care.
- 4. Actively collaborates with First Nations community elders and organisations to ensure best practice
- 5. Role models a continual learning journey of building cultural awareness and competency within the home and/or team

Applications must address all the above criteria in their category to be eligible.



Supporting documents

All applications <u>must</u> include at least two supporting documents, at least one of which must come from an external organisation/person.

Tell us the story in your nominations! A letter from a young person, photos of the home or videos of Carers sharing about their work help to enrichen your nomination.

Please refer to your supporting documents in your written nomination and ensure they are relevant to the criteria questions.

Referees

A maximum of two referees must be provided for each nomination. At least one referee should be external to the nominee's workplace. References for short-listed nominees will be checked.

Endorsement of the Chief Executive Officer must be obtained for nominations to be accepted.

The Judging Panel

The Judging Panel will comprise members of the RCLDS Committee, representatives of the Centre for Excellence in Child and Family Welfare, Department of Families, Fairness and Housing and the Department of Education. No member of the judging panel may have a nomination from their Agency in consideration.

Finalist notification

Finalists will be notified 3 weeks prior to ResiROCKS Forum via The Centre's social media pages. Finalists must attend on the day (Thursday 10, October 2024). Teams that are finalists in the Residential Team will be provided with tickets for two representatives.

The Awards

The 7 major Award Category Winners will each receive:

- An engraved award
- A framed certificate for the winner's Community Service Organisation office

The decision

The RCLDS Awards Judging Panel will consider the information provided on the nomination form and supporting documentation and may request additional information to assist in the decision-making.

The decision of the Judging Panel is final, and no correspondence will be entered into.
